- 2. PAYMENTS** Upfront Fixed Term Program Agreements require payment in advance for the program supply period outlined in the agreement.
- 3. CANCELLATION / SUSPENSION** Fixed Term programs can not be canceled, transferred, suspended or deferred. Furthermore, there is no reimbursements, credits or make-up classes provided for missed programming.
- 4. DISPUTES** All disputes regarding the Fixed Term Program Service Agreement should be referred to the Fleurieu Aquatic Centre in person, by telephone 08 7078 4150, or mailed to the Fleurieu Aquatic Centre, Lot 50 Ocean Road, Hayborough 5211 or via your nominated Financial Institution.
- 5. ENTITLEMENT** Provision of services provided by the Centre may change and for the purposes of this Contract is based on "entitlement" to use and not on actual use. By signing this agreement you are agreeing to be bound by the rules and conditions of the Centre. The Management at the Fleurieu Aquatic Centre reserves the right to cancel the rights of any member not complying with the conditions of membership or rules of the Centre at any time.
- 6. PROVISION OF SERVICE** Change of location or ownership or the name of the Centre does not absolve you of your responsibilities under the terms and conditions of this Contract.
- 7. ENTIRE AGREEMENT** This Contract and DDR Service Agreement constitute the entire agreement, understanding and arrangement (express and implied) between you, the Customer, the Fleurieu Aquatic Centre relating to the subject matter of this Contract and supersedes and cancels any previous agreement, understanding and arrangement relating thereto whether written or oral.
